Pompidou Center in Metz (France) on May 5th and 6th, 2019

Program subject to evolutions

In view of the Biarritz Summit, which will take place from 24 to 26 August 2019 with the Heads of State and Government of the seven member countries (Canada, France, Germany, Italy, Japan, United Kingdom, United States) and the European Union, a G7 summit of the environment is organized on 5-6 May 2019, at the Robert Schuman Congress Center in Metz. In addition to G7 members, other countries are invited on this occasion. Priority will be given to combating inequalities through the protection of biodiversity and climate.

Events will be dedicated to civil society and the general public and open to the participation of national delegations: they will also be held May 5-6 at the Center Pompidou Metz in the immediate vicinity of the Robert-Schuman Congress Center¹.

The organization of G7-Environment is part of a sustainable development approach, with reference to the ISO 20121 standard.

The Pompidou Center is included in the G7 Environment security perimeter.

Members of G7 national delegations are strongly encouraged to attend and participate. In particular, several groups of G7 commitments, representing civil society, wish to have exchanges with members of these delegations, especially during the session of Sunday, May 5 organized in the room The Studio (250 seats with simultaneous translation French English)., in the Pompidou Centre. Building a harmonious and peaceful global civilization will be the work of society as a whole, with all its components - not just national governments.

This day will allow, as is rarely the case in the G7, to hear representatives of civil society from diverse backgrounds (companies, scientists, think tanks, NGOs, ...) and all categories. The public will receive the messages, which will be delivered the next morning, Monday 6 May, to the environment ministers of 15 countries and to the European Commissioner in charge of the environment.

The life of each and everyone is here and now! Think global, act local.

The restoration of balanced relations between human activities and the biosphere is inseparable from social justice, solidarity and inclusivity. This is played out at different scales of space and governance but the territory and its inhabitants constitute the real element, the basic brick. The City of Metz, the Metropolis of Metz, the Department of Moselle and the Great East Region are experimenting and daring to undertake to develop their territories, to contribute to achieving the objectives of sustainable development, carbon neutrality, but also to protect the living and biodiversity. 3 / Living Earth (ocean, biodiversity, climate)

The Anthropocene is a fact, which humanity becomes aware of in this 21st century.

Beyond the sectoral and disciplinary divisions or borders, there is our Earth with its dynamic equilibrium, a rather stable climate system since 12 000 years and a rather stable biodiversity since ... millions of years until the action of humans, very recently, disrupts in an extremely short time these balances modifying the climate and triggering a massive extinction of biodiversity. A series of current topics concerning oceans, biodiversity and climate will be covered with, above all, many lines of action and solutions, to be implemented as quickly as possible, across the planet.

The Ocean and Climate Platform (POC) is organizing this event and will carry out an inventory with solutions for the mitigation and adaptation to climate change, on themes not taken into account in the international agenda, in parallel with the Marine Litter Workshop whose experts could work alongside other NGOs. The aim is to connect and boost exchanges between civil society actors, the scientific community and policy makers to accelerate the implementation of concrete measures for the preservation of the ocean.

More energy efficiency for less greenhouse gases.

According to the International Energy Agency, the energy needs for air conditioning could triple by 2050 if nothing is done. Air conditioning contributes to climate change in two ways: on the one hand, through he refrigerants used -mostly greenhouse gases - and, on the other hand, through energy consumption. This event will highlight the importance of substituting these greenhouse gases and improving the energy efficiency of air conditioning equipment. Examples of good practice will be presented.

Financing for biodiversity must prevail.

As with climate policies, the tools of finance must be used to transform infrastructure, reorient investments, and create leverage for biodiversity. The values "life" and "biodiversity" must dominate the values "euro" or "dollar". WWF and AXA have produced, at the request of the G7, a study on the financing of actions in favor of biodiversity. The OECD is working on the same subject. The results of these two studies, presented to the G7 ministers during the Metz meeting, will be presented to the public by the representatives of **WWF**, **AXA and the OECD**.
