This form shall be sent to dsac-nav-bf@aviation-civile.gouv.fr , with the following attachments:

- Airworthiness document issued by the State of registry, along with the associated validity certificate and/or operating limitations, as applicable
- Proof of payment of the applicable fee

Notes:

- The concerned aircraft shall hold a current airworthiness authorisation (e.g. restricted airworthiness certificate, permit-to-fly etc.) issued by the State of registry.
- The validation of the State of registry authorisation for the overflight of France takes the form of a permit-to-fly issued by the DGAC.
- DGAC permit-to-fly may include limitations additional to those associated with the State of registry authorisation.
- DGAC permit-to-fly is issued without prejudice to any applicable regulations other than airworthiness (including operational, crew licensing and airspace regulations).
- The pilot must hold an aeronautical title issued or recognised by the authority of the State of registry. If the pilot's aeronautical title under which they pilot the aircraft has not been issued in accordance with ICAO Annex 1 or European regulations, an authorisation from DSAC's Aircrew Directorate (DSAC/PN) is required before any flight under this permit-to-fly.
